# Metropolitan Coal operations update – Stephen Love, Environment & Community Superintendent and Mick Boyd, CHPP Manager

A presentation was provided to the CCC with an update regarding:

- Completion of Longwall (LW) 303 and planned commencement of LW 304 in late July 2019;
- Future LW 305-307 layout including narrower longwall blocks and wider pillars;
- Installation of groundwater wells and commencement of polyurethane (PUR) grout injection at Eastern Tributary (ET) crossing;
- Planned monitoring of upland swamps including soil moisture probes and flow gauges;
- Efforts to increase water recycling and reduce potable water consumption at Metropolitan;
- Recent changes to owner/operator status of site Coal Handling & Preparation Plant (CHPP) and stockpile, as well as trucking operator;
- Recent successful Resources for Regions grant to Wollongong City Council (WCC) for Helensburgh Town Centre upgrades; and
- Recent sponsorships to Helensburgh community organisations.
- PT asked what depth the groundwater wells at ET were drilled to. SL explained that all wells were drilled to a depth that reached 20m below the surface of the stream bed.
- KB enquired if WCC could utilise road maintenance contribution funds provided by Metropolitan to repair the Princes Highway where Metropolitan trucks muster during weekday mornings. JD confirmed that this was the case.
- AH commented on the difficulties faced by WCC implementing the planned upgrades due to traffic flow and parking problems in the town centre. New library to include a dedicated space for Helensburgh District Historical Society to provide information on the history of Helensburgh including the mine.





## **General business:**

AH requested that a visit be arranged to observe Eastern Tributary. SL and JD confirmed that this should be possible at the next CCC meeting and details would be provided prior.
