

Introduction

The *Protection of the Environment Operations Act 1997* (POEO Act) requires that holders of an environment protection licence make their pollution monitoring data publicly available in a timely manner.

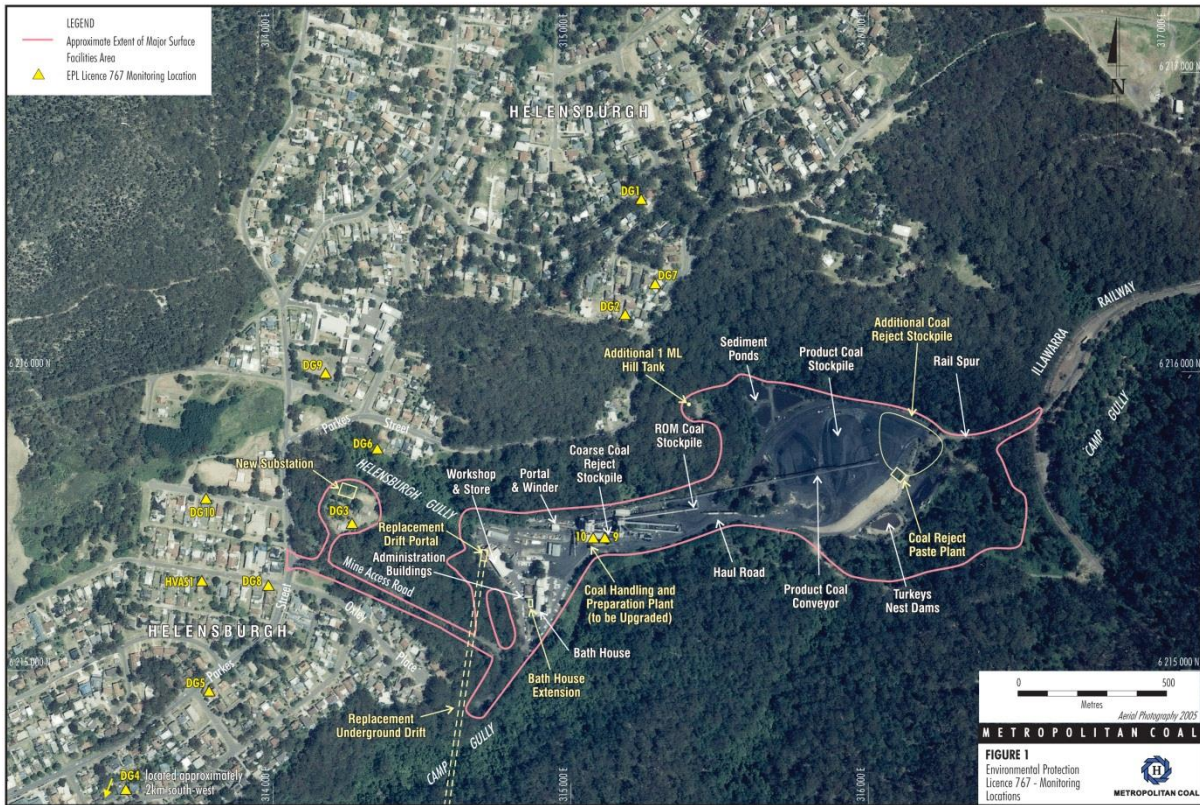
Metropolitan Coal is holder of Environmental Protection Licence 767 (EPL 767). This licence pertains to ‘Mining for Coal’ and ‘Coal Works’. EPL 767 identifies a number of monitoring points as shown in **Table 1 and Figure 1**.
