

Introduction

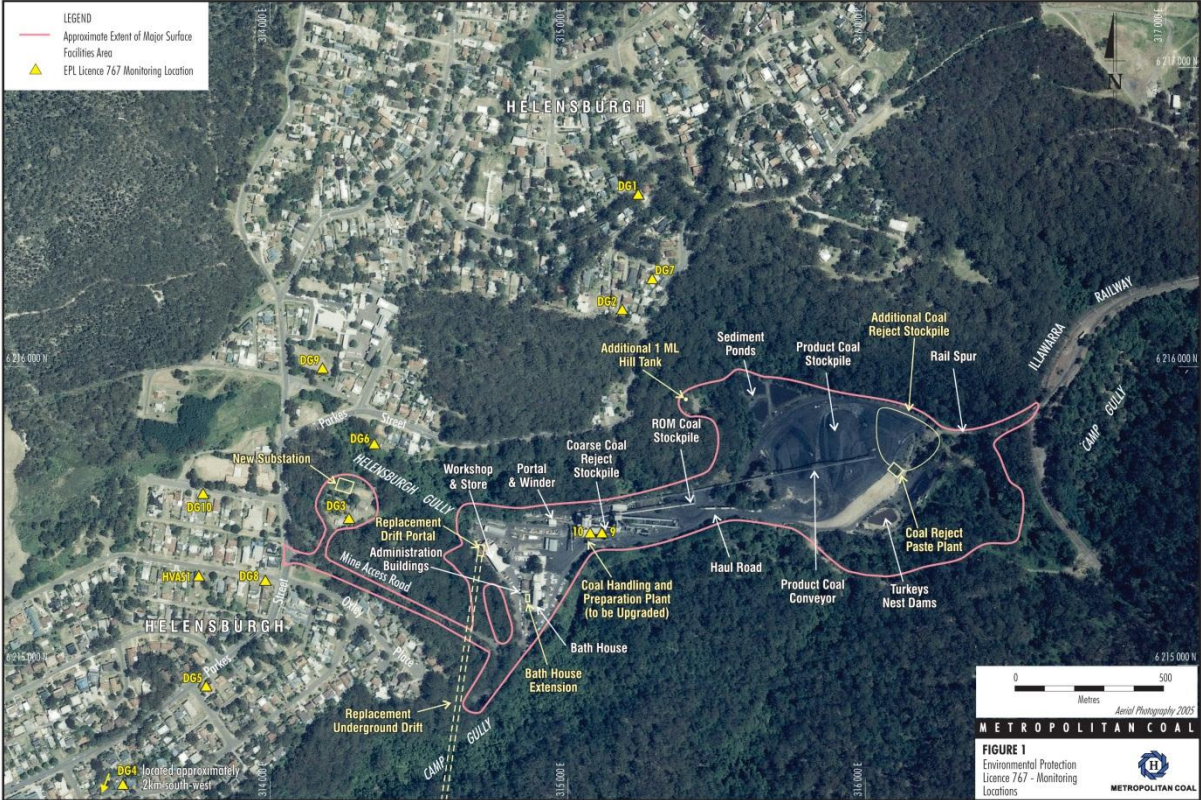
Metropolitan Coal is holder of Environmental Protection Licence 767 (EPL 767). This licence pertains to 'Mining for Coal' and 'Coal Works'. EPL 767 identifies a number of monitoring points as shown in **Table 1 and Figure 1**. Metropolitan Coal is located Off Parkes Street Helensburgh, NSW, 2508.
