- If you are listed as a nominated responsible person for a company that has obtained an explosives licence, and you cease to be an employee, the company must notify SafeWork NSW within 14 days.

If the licence is lost, stolen or destroyed, you are required to apply for a replacement licence. An application to replace an explosives licence is on our website.
