- (BS) How much time is left before Pit 6 is finished? (KB) Pit 6 will be mined until approximately 2030. (KD) What happens to the noise monitoring network once Pit 6 has been completed? (KB) The noise monitoring network will remain in place until the end of the mine life.

 - (BH) Are vehicles being used/focused in less pits during the night (less vehicle spread)? (KB) The spread of heavy vehicles across the pits remains consistent throughout the 24-hour period, however support type vehicles are less during the night compared to the day.
 - o (BS) Have any complaints been made from the Cooyal area? (KB) No complaints recorded from this area since 2020
 - (BS) How often is real-time monitoring data compared to predicted data? (KB) The requirement under our operating conditions is an annual comparison.
- Attended Noise Monitoring Summary of Compliance 28 29 July 2022.

- (BS) What is the process for an exceedance? (CP) If the initial measure is classed as an exceedance; a retest is required within 75 minutes to determine a non-compliance. A non-compliance is reported to the Department.
- (BS) If the A-weighted result is exceeding the limit, is the requirement for a C-weighted measurement then taken? (CP) Both A and C weighted measurements are taken during noise monitoring at each site for audible or measured mine noise and regardless of an exceedance. The comparison of C-weighted and A- weighted levels is to determine if modifying factors should be applied in accordance with the NPfl. In the Attended Noise Monitoring Report there is a confirmation that this assessment was carried out and if modifying actors were applied to a monitoring site noise level (i.e., LAeq, 15 minute).)

- (BS) What triggers a review of the management plans? (KB) This particular review stems from the Annual Review. It is a condition of WCPL's Development Consent that Environmental Management Plans are reviewed annually at a minimum.

- 100 Ha rework of existing rehabilitation to final biometric vegetation types (BVT)
- Total 143ha.

- (BS) Are there plans to go ahead with the Cumbo Creek relocation? (KB) The relocation is not feasible at this stage.

<u>WEP - Rehabilitation Strategy</u>

- Revised Rehabilitation Strategy
 - o Addressed some questions from DPIE Water's review
 - o Provided update regarding cooperation with Moolarben on integration of final voids
 - Awaiting approval
 - Map of proposed conceptual landform presented

MLA 616

- Covers ~70 ha in NW corner yellow polygon on map presented
- Last required Mining Lease for WEP approval area
- Final Survey plans submitted to MEG

EL 9399

- Assessable Prospecting Operations (APO) Approved 2 August 2022
 - o Covers 89 holes
 - o Up to 3 drill rigs only 1 rig confirmed at this stage
 - o Drilling 6.30am to 6.30pm 7 days
 - o Drilling to commence 19 Sept 2022
 - o Each rig supported by a light vehicle and 2 light trucks
 - o Approx. 12-month program
 - o All holes drilled with above ground sumps
 - o Working on next APO for the remaining holes, approximately 160.
- IF to provide notification of any additional drill rigs.
- (BS) What is the overall length of the program? (IF) Approximately three years based on two operating drill rigs. This is dependent on weather conditions and rig availability, includes rehabilitation.

<u>Property Management – Feral Animal Control</u>

- Working with LLS on an aerial shooting program likely to commence in October
- A map of the potential coverage area was presented

Property Management - Demolition

- 5 houses identified as per the SIMP (2 Bedes Lane, 3 Fitzgerald Street, 9 Price Street, 17 Barigan Street, 19 Barigan Street)
- Asbestos removal commenced in July
- Process repeated from previous years;

- Licensed asbestos contractor
- Licensed hygienist to monitor
- o Inert waste in pit
- (BS) What is the likelihood of asbestos waste being disposed of within pit, i.e., becoming a licenced asbestos disposal facility? (IF) No chance due to the approval and legislative requirements that would need to be satisfied.

 - o Commenced field work for geo tech and environmental assessments
- Will the ECA areas be impacted by the widening of the powerline easement? (IF) Yes, Energy Co are responsible for arranging their own biodiversity offsets. Excised offset areas will be included in the Energy Co offset calculations.
